## **IMPORTANT**

"All Risks" cover on hand tools and equipment, including Stock in Transit, has historically been an add on section to your Contractors Combined Insurance.

Limits of cover have been £2000 - £4000 maximum for hand tools.

With your present insurers there is an excess of £1000 minimum for tool claims, Effectively removing your ability to claim for losses under £1000.

On investigation we also have been made aware that because of the value of modern machinery and equipment carried by our contractor clients the £1000 limit is far too low.

Here is an example of the current premium costing for £2000 Sum Insured with an £1000 excess charged on your Contractors Combined if you have selected tools cover -£108.19 (inc. tax).

All Insurers do place conditions on the Policy such as the use of tool safes bolted into the vehicle, vehicle security and locking clauses.

There must always be evidence of a break in to the vehicle. Tools suddenly going missing on site are not insured.







## The Future -'Multi-Uso' Cover



We have spoken to various Insurers, many of whom were not receptive to providing cover especially for tools.

After much open market research we are able to offer you our important client, a new style Policy cover.

£5,000	£10,000	£10,000	£5,000	£5,000		
Excess £350.00 Annual Premium £450.00 + tax at 12% = £504.00 + Policy Fee £20.00 = £524.00
